□ 1,10,828 crore GST Gross Revenue collected for January, 2020

January 2020 stands second highest monthly collection since implementation of GST

The gross GST revenue collected in the month of January, 2020 is \Box **1,10,828 crore** of which CGST is \Box **20,944 crore**, SGST is \Box **28,224 crore**, IGST is \Box **53,013 crore** (including \Box **23,481 crore** collected on imports) and Cess is \Box **8,637 crore** (including \Box **824 crore** collected on imports). The total number of GSTR 3B Returns filed for the month of December up to 31st January, 2020 is **83 lakh (prov)**.

The government has settled \Box 24,730 crore to CGST and \Box 18,199 crore to SGST from IGST as regular settlement. The total revenue earned by Central Government and the State Governments after regular settlement in the month of January,2020 is \Box 45,674 crore for CGST and \Box 46,433 crore for the SGST.

The GST revenues during the month of January, 2020 from domestic transactions has shown an impressive growth of 12% over the revenue during the month of January, 2019. Taking into account the IGST collected from imports of goods, the total revenue during January, 2020 has increased by 8% in comparison to the revenue during January, 2019. During this month, the IGST on import of goods has shown a negative growth of (-) 3% as compared to January, 2019. This is only second time since introduction of GST that the monthly revenues have crossed \Box 1.1 lakh crore and sixth time during the year it has crossed \Box 1 lakh crore.

The chart shows trends in revenue during the current year. The table shows the state-wise figures of GST collected in each State during the month of January, 2020 as compared to January, 2019.
